AGUILAR PLAINTIFFS' STATUS UPDATE
REGARDING DOMINICAN REPUBLIC PROCEEDINGS

Pursuant to paragraph 4 of this Court's Order . . . Requiring Filing of Papers Submitted in the Dominican Republic [DE-257], the *Aguilar* Plaintiffs file this status update regarding the Dominican Republic proceedings.

As the Court is aware, there was a hearing scheduled for May 21, 2009, in the Dominican Republic on Defendants' action to set aside the Dominican Freeze Order. In anticipation of that hearing, the Dominican Court set a deadline of May 20, 2009, for the parties to submit

documents in support of, or in opposition to, the action to set aside the freeze order. Defendants did not file any documents in support of their petition to dissolve the restraining order prior to expiration of the deadline. This morning, Defendants moved for an enlargement of time. The Dominican Republic Court subsequently extended the filing deadline to Monday, May 25, 2009, and re-set the hearing for Tuesday, May 26, 2009.
